IMPORTANT NOTES – before completing the Continuation Sheet for Trust Deeds - Absolute Beneficiaries, please read the Important Notes in the Trust Deed and the following notes.

1. This Continuation Sheet must only be used in conjunction with the Absolute or Flexible Trust Deed that you are creating and should be attached (bound or stapled) to it.
2. You must also add the following words to the Trust Deed: '**and see also Continuation Sheet incorporated into this Deed**'. You must write these words at the end of Clause 4 in Part B of the Trust Deed relating to Absolute Beneficiaries. The Settlor/Donor and all the Trustees must initial by this change to the Trust Deed.
3. The Settlor/Donor and all of the Trustees must also sign at the end of the Continuation Sheet before the Trust Deed is dated in Part A.
