How to access the L&G Guided Retirement Planner

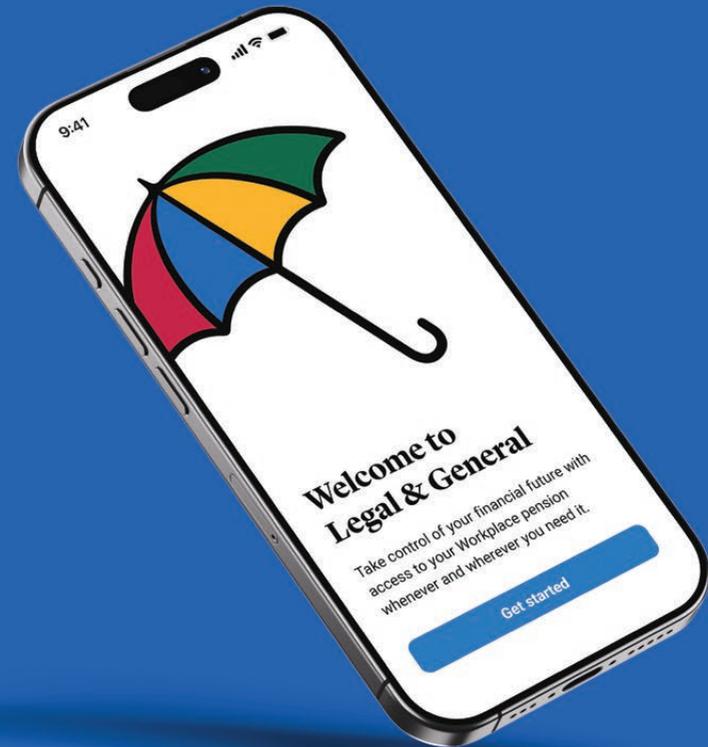
