# Introducing Legal & General Modular Homes

Legal & General will be familiar to most people as one of the UK's largest financial services groups, but we have also invested over £19 billion in projects including homebuilding, urban regeneration, clean energy and small business finance. As a group, we've been involved in housing for a long time: developing homes, financing the affordable housing sector, and now building modular homes.

Our modular homes are built in our factory at Sherburn-in-Elmet, Leeds. Our modular approach means we can halve build time, minimise disruption from a normal building site environment and by standardising and simplifying our process, we can drive up quality. Our homes are designed to keep energy and water consumption down, reduce greenhouse gases and the waste that households produce. The materials we use are sustainably sourced and the way we landscape our sites adds to biodiversity.





### You may have seen some activity on site over the last few weeks, as we have been clearing the site of rubbish, old structures, invasive species (Japanese Knotweed), asbestos, scrub and trees in anticipation for groundworks starting.

Trees recommended as unsuitable for retention are being removed, and the timber retained where possible to support the new play areas and furniture, such as benches. The trees that are being retained on site will be protected by fencing for the duration of the works. This will prevent damage to both the trees and their roots. A Tree Survey by an independent Arboricultural Consultant has been carried out, and the tree planting strategy proposes that any new trees planted are in excess of the mitigation for tree loss calculated by Bristol City

Council's Tree Replacement Strategy

To facilitate the construction of the new cycle path, we have applied to close the existing route for around six months due to start in April. We will do our best to complete this work as guickly as possible and will notify residents of the exact date in due course. Cyclists and pedestrians are advised to re-route to Wordsworth Road via Constable Road and Bonnington Walk.

### Protecting wildlife

With discussion and agreement from Bristol City Council, we have now carefully relocated 298 slowworms from the area that will be developed to the SNCI. This involved erecting a reptile fence, clearing scrub and trapping the site.

We have and will continue to implement a range of measures to protect the ecology of the site. Our Ecological and Arboricultural Consultant will be visiting and monitoring the works, to ensure there is no impact on any of the site's fauna. This includes undertaking regular checks for fauna, and in particular badgers and bats.


### We're delighted to be delivering a brand new neighbourhood off Bonnington Walk, Lockleaze.

# Considerate Constructors



We are aware that our work can sometimes be a source of disruption if not managed carefully and will do our very best to ensure this is kept to a minimum. We are registered as a member of the Considerate Constructors Scheme and commit to care about appearance, respect the community, protect the environment, secure everyone's safety and value our workforce.

#### Normal working hours will be 08:00 - 18:00 hrs Monday to Friday and 08:00 - 13:00 hrs on Saturdays. No work will be undertaken on Sundays. During this time there will be full time management supervision, and gate personnel on site at all times.

Gordons Transport Ltd will be working with our team to deliver the modular homes to our site. This will involve a number of abnormal loads under police escort and while this may cause some inconvenience, it does reduce the number of construction material deliveries over a longer period. Gordons Transport will be contacting nearby residents with the dates/ times of abnormal load movements, as well as details of any road closures and if vehicles need to be parked elsewhere. #### September


